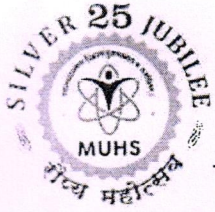

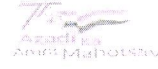

Amravati-444606, Maharashtra has functioning since 1973 submitted an application for permission for sanction of 75 seats in BHMS course for the academic year 24-25. The College has submitted the Part 1 information in which the entire functional profile has been narrated. MARBH has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under clause 28 of NCH Act 2020.

On Careful examination of the report, the Medical Assessment and Rating Board have Observed Following shortfalls.

**A. Hospital details:-**

- Case records should be maintained with demographic details of the patient such as name, age sex, address, phone number etc.
- Aquittance Roll of Hospital Staff is not uploaded. Copy of the same may be submitted for verification.

**B. Teaching Faculty:**

- Attendance of Dr. Anmol Bhaskar, Dr. Shilpa Rajendra, Dr. Pallavi Dhiraj, Dr. Priti Nilesh, Dr. Pravin is not Uploaded.

**C. Miscellaneous:-**

- College has not enabled The Aadhar Enabled Biometric Attendance system. The same shall be implemented in one month of time.

All the shortfalls observed in your College shall be rectified within a period of 30 days and compliance report shall be submitted to the MARB. Considering the above observations, and facilities available, MARB has decided to issue **Conditional Permission** to Shri Takhatmal Shrivallabh Homoeopathic Medical College HomoeoSadon, Rajapeth, Distt. 444606, Maharashtra for BHMS course for the academic year 2024- 25 with intake capacity of 75 seats.

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity 75 seats for BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/ UT govt as designated by Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted there under.

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by Medical Assessment and Rating Board.

Permission to the college can be withdrawn or denied in the subsequent year if college is found deficient in compliance to MSR2013 any time during the Academic Year.



With reference to the letter No.Inspn/Hom/BIHMS/Maharashtra/Hom Desk dated 22.7.1992 from State Govt., I am directed to say that the Central Council has decided to recognise the three Homoeopathic Medical Colleges namely Mohini Homoeopathic & Charitable Society's Homoeopathic Medical College, Rajpeth (Amravati), Homoeopathic Medical College, Akot Road, Akola and Panchsheel Homoeopathic Shikshak Prasarak Mandal Homoeopathic Medical College, Buldana respectively for B.H.M.S. Direct Degree Course subject to the conditions that the State Government and the Amravati University shall ensure that these colleges have made appointment of full strength of teaching staff possessing requisite qualification and teaching experience as per provisions of Homoeopathy (Minimum Standard of Education) Regulations, 1983 for direct degree course and also that the prescribed student-bed ratio of 1:1 is maintained by them.

The Central Council further decided that the recognition of these colleges can be withdrawn by it at any time if the colleges fail to meet these conditions.

It is, therefore, requested that the State Govt. and the University may ensure that the above colleges may provide the minimum requirements, norm and standards including the above immediately and a report of compliance duly verified by the University be made available to this Council before 1st November, 1993.
